Earnest Money Deposit (EMD) as indicated against the item in the form of a Bank Draft/Pay Order in favour **Bhagwan Mahaveer Viklang Sahayata Samiti** payable at **New Delhi** is required to be submitted with the bids. The amount of EMD would be returned to the unsuccessful bidders. Offers not accompanied by EMD are liable to be rejected.
3. The period of supply would be from 20.05.2016 to 31.03.2017.
4. The supplies would be made as per the supply order by the Samiti. The time allowed for the supply of would be 10 days. If the supplies are not made within the stipulated period, the order would be treated as cancelled and the Samiti would be free to purchase from some other party at the risk and cost of the supplier.
5. Inspection and certification of the materials to be supplied by the Supplier would be carried out by the Samiti. Bills of the suppliers will be passed on basis of inspection report.
6. The payment would be made to the supplier by Cheque drawn on any Bank in Delhi within one month from the date of the receipt of the bill from the Supplier and inspection of materials.
7. The samples of the material required by the Samiti can be seen in the store of the Samiti between 11 A.M. to 3.00 P.M. on all working days from 26.04.2016 to 16.05.2016.
8. The Bidder is required to submit a sealed sample of the material/item to be supplied by him along with the tender. He should also provide the name and address of manufactures and technical specifications where available. The sample of the unsuccessful tenders would be returned back and the sample of the successful tender would be retained and at the approved rate.

9. The Samiti reserves the right to split the order for the supply of materials between more than one parties.
10. Employees of the Samiti along with their close relatives are debarred to participate in this tender.
11. The Samiti reserves the right at its sole discretion to reject any/ all tender(s) without assigning any reason and does not bind itself to accept the lowest tender or whole of the tender or part of the tender without assigning any reason.
